

Accreditation

Dixie State University has been accredited by the Northwest Commission on Colleges and Universities since 1945. DSU's latest reaffirmation of accreditation was awarded for its Comprehensive Self-study and site visit in Fall 2012. In January 2014, the institution had its Year One Mission and Core Theme Report approved and in January 2016, its Mid-cycle Report was approved. The next Comprehensive Self-study and site visit will take place in Fall 2020.

Accreditation of an institution of higher education by the Northwest Commission on Colleges and Universities indicates that it meets or exceeds criteria for the assessment of institutional quality evaluated through a peer review process. An accredited college or university is one which has available the necessary resources to achieve its stated purposes through appropriate educational programs, is substantially doing so, and gives reasonable evidence that it will continue to do so in the foreseeable future. Institutional integrity is also addressed through accreditation.

Accreditation by the Northwest Commission on Colleges and Universities is not partial, but applies to the institution as a whole. As such, it is not a guarantee of every course or program offered, or the competence of individual graduates. Rather, it provides reasonable assurance about the quality of opportunities available to students who attend the institution.
